General Information

Welcome to Cyber Rally-O Juniors Division!

The Juniors Division is for handlers under the age of 18 years. Requirements for qualification in rally and dance are lower than for adults. The Juniors Division offers entry fee group discounts as well as a \$5.00 discount for single entries and registrations.

Other than as specified below, all Rules and Guidelines for the Rally and Dance Divisions apply. Please read the appropriate Rules and Guidelines before entering.

Registration Fee

Dogs must be registered to enter Cyber Rally-O. Follow the registration instructions on either the Rally or the Dance Rules and Guidelines. Once registered, the dog is eligible for all Divisions.

Junior handlers registering their dogs receive a \$5 discount (\$10 for each dog instead of \$15).

Registrations are permanent, and the dog's registration number is valid for all CRO divisions.

Entry Fees

Junior entries are \$15 each. The following group discounts apply:

3-9 entries on the same course	\$12 per entry
10 or more entries on the same course	\$10 per entry

For multiple entries, a single package for the optional ribbons/medals will be sent to a single address.

Titles, Certificates, Ribbons, and Medals

Juniors will receive the same CRO ribbons, medals, and certificates as adults. All titles earned by Juniors will be preceded by the letter "J". For example, the Level I rally title will be "J-CRO-I." The Preliminary dance title will be "J-CRO-Preliminary."

Judging Standards for Juniors

Qualifying standards are less strict for the Juniors Division than for adults. In both CRO Rally and CRO Dance, a judge may use his/her discretion to modify any rule(s) which the judge feels should be modified for the Junior team being judged.

Judging and Qualifying/NQ - Rally

In the Rally Divisions, Junior teams are permitted to do three stations incorrectly on any course at any level and still have a qualifying run.

All other CRO Rally rules apply except as relaxed by the judges in their sole discretion.

Judging and Qualifying/NQ – Dance

In the Dance Division, Junior teams must demonstrate accuracy of moves, pattern, position, and artistry as follows:

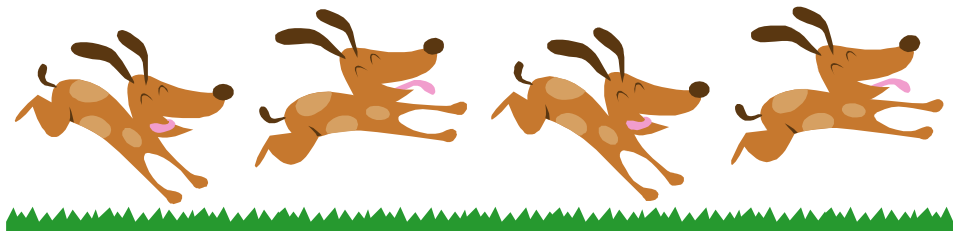
Moves	65%
Pattern	65%
Position	60%
Artistry	65%

All other Dance rules apply except as relaxed by the judges in their sole discretion.

Parental Consent

Juniors must have a parent or legal guardian/custodian submit a Parental Consent form (attached) prior to submitting any entries. The form must have an original signature and be mailed (not e-mailed) to Cyber Rally-O c/o J. Azaren, 49 Toledo Lane, Willingboro, NJ 08046. Receipt of the form will be acknowledged by e-mail to the person signing the form. The junior is then eligible to submit entries with the named dog, provided the dog is registered with CRO.
